- The Company is predominantly engaged in the business of manufacture and sale of Indian Made Foreign Liquor (IMFL) and its related products, which constitute a single business segment and therefore, disclosure under Accounting Standard (AS-17) on "Segment Reporting" issued by the ICAI is not applicable.

- 10 As per the requirement of Schedule II of the Companies Act, 2013 effective from April 01, 2014, the Company has charged depreciation based on the useful lives. Consequently, depreciation charge for the quarter ended June 30, 2014 is higher by Rs. 126.03 lacs due to change in the useful life of certain assets.
- During the quarter, the Company has allotted 503,195 equity shares to option grantees against exercise of vested stock options.
- 12 Employee benefits expense includes the provisions for Employee Retirement Benefits on pro-rata basis.
- 13 Pledged/encumbered shares of promoters as on March 31, 2014 and June 30, 2014 includes 1,065,000 equity shares held by Karvy Financial Services Limited under POA as collateral securities.
- The figures for the quarter ended June 30, 2014 are not comparable with those of the corresponding period of the previous year due to sale of entire stake held by the Company in its wholly owned subsidiary i.e. P.P. Caps Private Limited on January 16, 2014.
- The figures for the quarter ended March 31, 2014 are the balancing figures between the audited figures in respect of the full financial year ended March 31, 2014 and the unaudited published year to date figures upto the third quarter ended December 31, 2013.
- The previous period figures have been regrouped and reclassified wherever necessary.
