कर्जत-जामखेड तालुक्यात निकृष्ठ दर्जाचे पानंद रस्ते झाल्याप्रकरणी अनेकांनी तक्रारी केल्या होत्या. तर जामखेड तालुक्यातील साकत, घोडेगाव येथील ग्रामस्थांनी तहसील कार्यालयासमोर आमरण उपोषण आंदोलन केले होते. आमदार प्रा. राम शिंदे यांनी ही बाब गांभीर्याने घेत पावसाळी अधिवेशनात लक्षवेधी प्रश्र उपस्थित केला. याप्रकरणी आमदार शिंदे यांनी उपमुख्यमंत्री फडणवीस व रोजगार हमी मंत्री भूमरे यांच्याकडे तक्रार करून चौकशीची मागणी केली होती.

याबाबत आमदार प्रा. राम शिंदे यांनी प्रसिध्दीपत्रक काढले आहे. कोट्यावधी रूपये खर्चाचे पानंद रस्ते करताना प्रत्यक्ष कोणतीही विहीत प्रक्रिया राबवली नसल्याचे निदर्शनास आले आहे. सदरची कामे निकृष्ठ दर्जाची झाली आहेत. जिल्हा नियोजन समिती अंतर्गत सन २०२०-२१ व २०२१-२२ या आर्थिक वर्षाकरिता लेखाशिर्ष इतर जिल्हा योजनेतून उपजिल्हाधिकारी (रोहयो) यांचेकडील प्रशासकीय मान्यताप्राप्त योजनेतील

कामांना मंजूरी दिली आहे. मात्र सदर रस्त्याची कामे निकृष्ठ दर्जाची झाली आहेत. या योजनेतून केलेली कामे ही अस्तित्वातील रस्त्यांपेक्षाही दर्जाहिन झालेली आहेत. या कामांच्या टिकाऊपणाची शाश्वती देण्यात आलेली नाही. या कामांमध्ये मोठ्या प्रमाणावर शासकीय निधीचा अपहार झाला असून, कामांची बिले बोगस लाभार्थींच्या नावे अदा केली आहेत. कामे यंत्रसामुग्रीने केली असली तरी या कामांचे लॉगबुक उपलब्ध नसल्यामुळे यात शंका निर्माण होत आहे. केलेली कामे ही ग्रामपंचायत आराखड्याप्रमाणे नसल्याने महाराष्ट्र शासन नियोजन विभाग, शासन निर्णयाच्या अटी व शर्तीचे पूर्णता उल्लंघन झाले आहे.

पालकमंत्री पानंद रस्ते व रोजगार हमी योजनेंतर्गत रस्त्यांसाठी कर्जत-जामखेड तालुक्यात राज्य सरकारकडून १४ कोटी रूपयांचा तर जिल्हा नियोजन विभागामार्फत ५ कोटीह्न अधिक निधी प्राप्त झाला आहे. मात्र पानंद रस्ते कसताना कोणतीही प्रशासकीय विहीत प्रक्रिया राबवली गेली नाही. रस्त्याच्या दर्जाबाबत कोणत्याही सबंधीत अभियंत्याच्या देखरेखीखाली काम झालेले नाही.

झालेल्या कामाचे मोजमाप अंदाजे करून ठेकेदारांना

पैसे अदा करण्यात आले आहेत. कामे करताना स्थानिक ग्रामपंचायतीला याबाबत काहीही कल्पना देण्यात आलेली नाही. संपूर्ण कामाची निविदा प्रक्रीया न राबवता कामाचे वाटप राष्ट्रवादी काँग्रेसच्या कार्यकर्त्यांना खिरापत वाटल्यासारखे देण्यात आल्याचा प्रकार समोर आला आहे. केवळ पैसे मिळवण्याच्या उद्देशातून करण्यात आलेली ही कामे अत्यंत निकृष्ठ दर्जाची करण्यात आली आहेत. तर काही ठिकाणी रस्तेच न करता, कामे कागदावर दाखवून बील काढण्याचा प्रकार घडला आहे. याबाबत ग्रामस्थांकडून वारंवार तक्रारी होवूनही केवळ लोकप्रतिनिधीच्या दबावातून स्थानिक प्रशासनाने या तक्रारींकडे दुर्लश केले होते. दरम्यान याप्रकरणी चौकशीच्या आदेशाचे कर्जत-जामखेडच्या जनतेने स्वागत केले असून यामुळे सत्य बाहेर येवून भ्रष्टाचाराला आळा बसण्यास मदत होणार असल्याची भावना सर्वसामान्यांमध्ये व्यक्त होत आहे. मात्र या चौकशी आदेशाने सबंधीत अधिकारी व तथाकथित ठेकेदारांचे धाबे दणाणले आहेत.
