This is in reference to the Outcome of Board Meeting held on July 29, 2025 for the approval of issuance of upto 1,43,80,000 (One Crores Forty-three Lacs Eighty Thousand) Equity Shares and upto 4,57,15,000 (Four Crores Fifty-seven Lacs Fifteen Thousand) Convertible Warrants on preferential basis and the said Outcome was filed with BSE Limited and National Stock Exchange of India Limited (collectively "Stock Exchanges") on July 29, 2025.

This corrigendum is being submitted to the Stock Exchanges regarding the disclosure made pursuant to the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November, 2024 regarding the pre-preferential shareholding of one of the proposed allottee i.e. Bhavini Ajay Shah holding 15,000 equity shares which was inadvertently & unintentionally missed out and revised post issue shareholding of proposed allottee(s) on fully diluted basis considering the 16,70,599 outstanding ESOPs.

Further, we wish to inform you that the Company has locked-in the entire prepreferential shareholding held by Bhavini Ajay Shah in terms of the provisions of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018.
